- 1. PIN/Folio: Write either your 22-digit PIN number or 10-digit folio number. If unknown, search our database or Website at <u>www.hcpafl.org</u>.
- 2. Date: Enter current date on form.
- 3. Tax Year: Place current year on form. After August 1, use next tax year as the date required.
- 4. Owners name/address: Place owner(s) name and property address. Place a current phone number, fax number or email address for contact information.
- 5. Owner signature: The owner of the property must sign the request.
- 6. Cut Out: If request is for <u>cut out</u> of property, check this box. A new legal description must be provided.
- 7. Join: If request is for join, check this box and answer the yes/no questions.
- 8. Reason: Provide a reason on the form for consideration of the cut out or join of the property.
- Note: Your request, once completed can be brought to one of our offices, be mailed or faxed in. We will accept requests at any time during the year.
