- 2. Complete the fillable Portability Application on the following page. Print, Sign it, and Send it to our office.
- 3. The Applicant completes Parts 1-3

Part 1 is on the New Homestead property.

Part 2 is on the Previous Homestead property. You will need the Parcel ID, PIN or Folio number from your former homestead property. You can find it on the TRIM notice or on the Real Estate Tax Bill or use the parcel record search.

If you moved to Hillsborough County from another Florida County, provide the most complete address you can and be sure to include the name of the County.

4. Once you have completed part 1-2, print the form, sign it (Part 3) and return it to:
